1. Experience in having successfully completed works as follows during the last five years ending 31 - 03 – 2019.
 - a. Three similar works (at least one of them should be for Central or State Government / Central or State Autonomous Bodies / Central or State Public Sector Undertakings) each costing
Not less than Rs 18.00 Lakh.

or

- b. Two completed similar works each costing not less than Rs 27.00 Lakh

or

- c. One completed similar work costing not less than Rs 54.00 Lakh

“Cost of work” for this clause shall mean completed cost as mentioned in the final bill including if any, carried out under single contract including cost of materials, if any, supplied by clients. However the cost of materials issued free of cost shall not be considered for calculating the cost of work.
