Sealed quotations are invited for the supply of the materials specified in the schedule attached. The rates quoted should be for delivery of the articles at the place mentioned below the schedule. The necessary superscription, due date for the receipt of quotations, the date up to which the rates will have to remain firm for acceptance and the name and address of officer to whom the quotation is to be sent are noted above. Any quotation received after the time fixed on the due date is liable to be rejected. The maximum period required for delivery of the articles should also be mentioned. Quotations not stipulating period of firmness and with price variation clause and/ or 'subject to prior sale' condition are liable to be rejected.

The acceptance of the quotations will be subject to the following conditions:

- 1. <u>ACCEPTANCE</u>, <u>AGREEMENT:</u> Acceptance of the quotation constitutes a concluded contract. - (b) Any sum of money due and payable to the contractor (including Security Deposit returnable to him) under this contract may be appropriated by the Purchasing Officer or any other person authorized by him and set-off against any claim of the Purchasing Officer or HOMCO for the payment of sum of money arising out of or under any other contract made by the contractor with the purchasing Officer or HOMCO or any other person authorized by HOMCO.
- 7. The prices quoted should be inclusive of all taxes, transportation, loading, unloading, duties, cesses, etc., which are or may become payable by the contractor under existing or future laws or rules of the country of origin/ supply or delivery during the course of execution of the contract.

8. PAYMENT:-

- (a) All payments to the contractors will be made by the Purchasing Officer in due course:
 - i. By RTGS or by cheques (at par cheques) of the State Bank of India / UCO Bank / any nationalized Bank having branches in Alappuzha.
 - ii. In the case of supplies from abroad by drafts as may be, arranged between the contracting parties.

 - (f) Or in the case of supplies from abroad by drafts or otherwise as may be agreed to
- (g) The firms will produce stamped pre-receipted invoices in all cases where payments (advance/ final) for release of railway receipts/ shipping documents are made through Bank.
