## **Terms & Conditions**

1. The tenders without tender cost and EMD will be primarily rejected.
2. Validity of offered rates should be not less than 12 months from the date of acceptance Tender.
3. Consignment shall be dispatched from factory godown on door pick up basis.
4. The supply will be normally in two types of Carton Boxes (a) For medicines in 100ml Bottles. The Box dimension is L-40.5 x W-35.5 x H-13.5 cm (b) For tablets and other items, the dimension is L- 38 x W-30.5 x H-20.5cm.
5. Cargo vehicle should be hygienic to carry Medicines. No toxic or hazardous materials or particles should carry along with the Medicine consignments.
6. The Cargo Agency should provide update status of the dispatched consignments as and when contacted by the Pharmacy officials.
7. Docket charge if any should be clearly mentioned in the hard copy.
8. Minimum chargeable weight per way bill should be separately mentioned in the hard copy.
9. No advance payment will be made.
10. Payment will be made on the successful and safe execution of supply with Proof of Delivery.
11. A penalty @ 1% of service charges will be charged on delay in transit per week after the proposed final date of delivery.
12. Additional expenses/charges at the delivery point if any should be clearly mentioned in the hard copy.
13. No revision of rate is allowed before the expiry of contract period.
14. No other charges will be allowed except that mentioned in the tender.
15. An agreement in Kerala Stamp paper worth Rs. 200/- is to be made by the approved tenderers.
16. Managing Director reserves the right to accept or reject the offer given by any of the parties.
17. Unloading should be arranged by the transporter.
18. Door delivery charges should be mentioned separately.
19. The medicine should be delivered safely without damage or leakage. If any damage/ leakage /loss happened, the transporter is liable to compensation the cost of such products.
20. Transporter must obtain acknowledgement from consignee stating that they have received the material in proper quantity, qualities and packing. Any damage reported apart from manufacturing defect during transit will be responsibility of the transporter; and liable to replace the material at their own cost; with transporting charges.
21. If any issues occur at check posts or any other palaces HOMCO will not be responsible.
22. Transporter should see that work in done properly and on time stipulated.
