Interested agencies are requested to submit your quoted rate (Govt. of Kerala G.O.(P) No.67/2021/Fin dated 28.04.2021 may be referred) and experience in this field with supporting documents on or before 30. Jan.2025.

Scope: Balance works in Setting up of new manufacturing unit located at Valiya Kalavoor, Alappuzha, for Homeopathic Medicines having Tablets, Liquid orals, Ophthalmic preparation (sterile) and ointment/cream of HOMCO, complying with cGMP and Revised Schedule M1 of DC act, establishing facilities for QC/QA & microbiology lab, including below works:

- 1) Overall Project supervision till project completion,
- 2) Project Roadmap preparation indicating major milestones,
- 3) Site supervision
- 4) Certification of Bills & Invoices,
- 5) Technical review & advice in tendering
- 6) DQ (design qualification) review& advice

- c) Raw material & Finished Goods Storage and its logistics inside the factory
- d) QC/QA lab, Microbiology lab and Lab equipments
- e) Balance Civil works (including Clean room wall & ceiling paneling works, Dynamic pass box etc.) and Water supply & Drainage works
- f) Balance Electrical & instrumentation works + Electrical Insp. liaison works

- g) Balance ELV, low current, ISP works
- h) Balance HVAC works (High side & Low side) and BMS
- i) Balance Fire Fighting & Fire Alarm works + Fire license
- j) Balance handing over & licensing works for Lifts
- k) Furniture works for Factory (as per cGMP guidelines) and furniture for office
- l) Setting-up of Offices, Engineer's rooms, Toilet block, Change-over rooms, Canteen, Rest room etc.
- l) Effluent & Sewage Treatment works and PCB license
